The Association held its National AGM on June 12th via Teams, and I would like to thank those members who gave up their Saturday morning to attend. Online meetings are never ideal, and can be difficult to chair, so I would like to thank Peter Watson for doing an admirable job in ensuring that everyone had the opportunity to speak. My thanks also to all the Officers who stood for re-election. We have a diverse Council, who will always put the defence of Public Health, Animal Health and Animal Welfare, as well as all our Meat Hygiene Inspector and our Veterinary colleagues first. I was delighted to welcome our latest Council member, Aneliya Watson to our Council meeting the day before too. We have also recently welcomed a significant number of new members from Northern Ireland, who work as Meat Hygiene Inspectors for DAERA. We are delighted to initially welcome them as members of our Scotland South Division. However, we are actively looking at the formation of a Northern Ireland Division, and were delighted to welcome John McKeever to our last Council meeting to observe how Council works. Thanks, should also go to Dr. Robert Huey, Chief Veterinary Officer for Northern Ireland, for his support of this development for his staff.

Planning for our 56th seminar is progressing, with the Trustees having put together a varied line up of speakers. Subject to any unexpected restrictions the seminar will go ahead as usual at Harper Adams University, over the weekend of September 10th to 12th. To fulfil the requirements of the University, we will probably have sole use of the campus. A provisional list of speakers and registration details can be found elsewhere in this edition. One change that we have introduced for 2021, is the ability to register via our website, which will be going live soon. This has the benefit of reducing postage costs, and assisting our Seminar Co-ordinator, by automatically generating an attendance database.

We have had to adjust some of the costs to attend the seminar this year. The Association will be making a formal response, and the Council have been formulating a number of questions to put to the OTP team. Peter Watson and I have also recently met with the senior members of the team and put forward some initial views. As a stakeholder, we will continue to engage with the discussion on the Future Delivery Model, and raise our concerns for the protection of Public Health, Animal Health and Animal Welfare. The latter of which only gets a brief mention so far. If you

have any views you would like to share with the Association, please contact your Divisional Secretaries or myself. We can then pass them on or include them in our response before the 23rd July.

One issue that seems to frequently make the news is the continued difficulties surrounding exports following our exit from the European Union. This has put particular pressure on our colleagues working in Northern Ireland. Following a discussion at the Midlands Divisional Meeting, we are currently in the process of organising a webinar on Export Certification. Further details will be announced when known. We already have one speaker arranged, but will be looking to have some more for the event.

Whilst on the topic of Webinars, our colleagues in the EWFC organised a very successful one in May. The subject was 'EU Food Safety and Sustainability under The Green Deal', and speakers came from the EU Commission, the IFA and TEAGASC. The event was well supported with over a hundred registered delegates. I was delighted to be able to help with the organisation, and the Association provided the use of our MS Teams account to host the event on the EWFC's behalf. Particular thanks should go to Sean Butler (EWFC President), Jan Homma (EWFC Webmaster) and Bruno Lagae (Belgium Vice President) for organising the session, and the EWFC Board for promoting across their member states. Unfortunately, the EWFC have taken the reluctant decision to postpone their congress in Kilkenny, Ireland in October, due to the continuing uncertainty surrounding international travel. It's hoped the congress can be rescheduled for the early part of 2022.
