This award is based on nominations from across the Agency, and is awarded to a Meat Hygiene Inspector who has gone above and beyond whilst carrying out his role in protecting Public Health, animal Health and Animal Welfare.

This year I'm delighted to announce that the award has been given to Stephen Holden for not only his work as an emergency relief MHI in the South East, but also his role carrying out unannounced animal welfare audits, and supporting the next generation of trainee Official Auxiliaries, both in plant and as an assessor for the training programme. Stephen also champions the use of technology to assist with accessibility within the Food Standards Agency. Apart from all that, Stephen is also a Trustee of the Association, our seminar co-ordinator and the South East Divisional Secretary. I'm sure you will join me in congratulating Stephen on winning this prestigious award for 2022.

The Food Standards Agency also have a Vet of the Year Award, having reintroduced it a few years ago. This year, I'm also delighted to announce that it has been awarded to Collin Willson. Collin is a leading authority on Animal Welfare, and a great supporter of the Association. As well as advising Government, Collin is the Welsh President of the British Veterinary Association and senior Vice President of the Veterinary Public Health Association. He is also the veterinary lead of the Food Standards Agency Welfare Assurance Team. On behalf of the Association, I would like to congratulate Collin on his award too.

The Food Standards Agency are also recognising staff from across the organisation at an awards ceremony in April. Included in several categories are staff members from Field Operations, both individual's teams and the entire directorate in the 'Hidden

Heroes' category for working throughout the pandemic with no service failures in any establishment. An achievement all frontline staff can be justifiably proud of delivering.

Whilst most of the restrictions have now been lifted, Covid continues to have an impact on our day to day lives. I doubt that anyone doesn't know someone who has either contracted this virus, or whose family has been affected by it. This year the Presidency is going to be handed over from Ireland to France. I would like to thank Sean Butler the Irish President, for doing a fantastic job despite all the challenges thrown at him by Coronavirus.

Elsewhere, the EWFC continues to keep a close eye on the EU Commission and any developments that will affect Food Inspectors across Europe, and its trading partners, to ensure that standards of Public Health protection are not allowed to be reduced.
